
Sir,

With reference to the above, it is informed that the point wise reply of the information asked by you is as under-

1. The total strength of MTS in Department of Publication is 145.
2. 46 (Forty Six).
3. The requisition for filling up 45 (33 in 2013 and 12 in 2015) posts of MTS has already been sent to Ministry of Urban Development for onward submission to SSC. But the said vacancies are yet to be filled up through SSC.
4. The candidates are yet to be nominated by SSC.
5. Four (4) appointments have been made on compassionate ground during the year 2005-2015.
6. The post of MTS came into existence after implementation of 6 CPC recommendation. The Recruitment Rule for the post of MTS in this Department has been published in the Gazette of India in November, 2012.
7. The information sought is not specific
8. 2014.
9. The information is available in 5 pages.
10. The information is available in 9 pages.
11. No MTS is working on contract basis at present.


