- b) Have you maintained vacancy based roster in respect of persons with disabilities in terms of judgment dt. 8.10.13 passed by Hon'ble Supreme court of India in Civil Appeal No. 9096/2013 titled as Union Of India & Anr. Vs. National Federation of the Blind & Ors. If yes, supply the copy of the roster.
- c) Please confirm as to whether you have reported to the Department of Personnel & Training in connection with Contempt petition No.499/2014 pending before Hon'ble Supreme Court of India titled as National Federation of the Blind Vs. Union of India a total number of 115 backlog vacancies for persons with disabilities out of which 28 vacancies (A-3, B-6, C-19, D-2) have been reported as backlog vacancies for persons suffering from blindness and low vision, 42 vacancies (A-6, B-19, C-17, D-0) have been reported as backlog vacancies for persons suffering from hearing impairment, 45 vacancies (A-5; B-18, C-20, D-2) have been reported as backlog vacancies for persons suffering from locomotor disability or cerebral palsy. If yes, please supply the relevant roster or notification or advertisement on the basis of which this calculation was made.
- d) Please inform whether you have informed DOPT that out of 115 backlog vacancies you have filled up 6 vacancies (VH-0[A-0, B-0, C-0, D-0] HH-


