- (a) Holding analogous posts on regular basis in the parent Cadre or Department; (i) or (ii)
  - With five years of regular service in the grade rendered after appointment thereto on a regular basis in Level 11 in the Pay Matrix as per the 7th CPC [pre-revised Pay-Band 3 of Rs.15600-39100/- (+) Grade pay Rs.6600/-] or equivalent in the parent Cadre or Department; and
- (b) Possessing the following educational qualifications and experience:
  - Graduate Degree from recognized University / Institutions; (i)
  - Master of Business Administration / Post Graduate Diploma in Management / (ii) Post Graduate Degree in Printing Technology.
  - Possessing eight years' experience in the field of Publication. (iii)

- (c) Deputation / Re-employment of Armed Force Personnel:
  - (i) The Armed Forces personnel of the rank of Lt. Colonel or equivalent who are to be transferred to reserve within a period of one year and having the qualifications and experience prescribed for deputation shall also be considered. Such persons would be given deputation terms up to the date on which they are due for release from the Armed Forces; thereafter they may be continued on re-employment.
- Period of deputation (including short-term contract) including period of deputation (including short term contract) in another ex-cadre post held immediately preceding this appointment in the same or some other Organization or Department of the Central Government shall ordinarily not exceed four years. The maximum age limit for appointment by deputation (including short-term contract) shall be not exceeding 56 years as on the closing date of the receipt of applications.
